3. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format (GFR 19-A) within 12 months from the date of this Sanction Order.

4. The State Government/UT Administration should ensure that the sanctioned amount is utilized within one month from the date of crediting of fund in the account of the State.

5. The State Government is required to furnish monthly return of this expenditure to this Ministry along with a report on amounts outstanding, released to the State Government under Merit-cum Means based Scholarship scheme.
