The non-recurring grant may be released to the Govt. of Jharkhand through CAS, Reserve Bank of India, Nagpur.

"3601" Grant-in-aid to State Governments, 02- Grants for State Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) -Other Grants (Minor Head), 01 - Multi sectoral Development Programme for minorities, 01.00.35 - Grant for creation of capital assets for the year 2016-17.

The State government should ensure that proportionate share of 50% of State share for the 3. projects mentioned at annexure -I is released to the implementing agency along with Central share.

A copy of the Utilization certificate of 1<sup>st</sup> installment is enclosed. Further it is certified that 4. no UC is pending for this project.

Utilization Certificate for this grant should be submitted by the grantee in the prescribed 5. format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and the requisitioned amount with milestones and time frame, should also be furnished.

The sanction is issued on the commitment given by the State Govt. that villages/locations 6. having a substantial minority population has been selected for the projects mentioned at Annexure-I and also that duplication will not take place.

The State Government should ensure that a board containing information as per Template 7. enclosed at Annexure-III is displayed at the site. After completion of projects, a permanent display would be installed.
