4. The organization shall provide Post Placement Support for period of one year and develop Management Information System as per scheme guidelines.

5. The PIA shall submit the Progress Report and Utilization Certificate in GFR 12 (A), as prescribed in para 7 of the Scheme "Nai Manzil Scheme".
