- The PIA will provide Post Placement Support for period of one year and develop Management Information System as per scheme guidelines.
- 8. No UC is pending in the Ministry in respect of PIA.
- The PIA shall ensure commencement of project within 30 days of sanction of first installment (40%) and furnish list of trainees in the format prescribed.
- The PIA shall submit the Progress Report and Utilization Certificate in GFR 19 (A), as prescribed in para 7 of the Scheme Seekho Aur Kamao.
