- The State Government should ensure that the sanctioned amount is disbursed 2. to the students within one month from the receipt of fund in the State Account.
- The utilization of the above amount by implementing agency is subject to the 3. following terms & conditions:-
- Scholarships will be available to the students of minority communities studying (i) in classes I to X. The continuance of award will be subject to securing 50% marks in the previous examination. Maintenance allowance will be provided to hostellers and day scholars. Maintenance allowance will be given for 10 months only in an academic year.
- The award will be discontinued if a student fails to secure 50% marks in the (ii) annual examination except in case of unavoidable reasons to be certified by the Principal/competent authority of the school and recommended by the State Government/Union Territory Administration.
- The annual income of the parents/guardian, from all sources does not exceed (iii) Rs. 1.00 lakh. Income Certificate issued by the Competent Authority declared by the State Government/ UT Administration or Income certificate from the employer for employed parents/guardian.
- Scholarship will not be given to more than two students from a family. (iv)
- If a student is found to have obtained a scholarship by false statement, his/her (V) scholarship will be cancelled forthwith and the amount of the scholarship paid shall be recovered, at the discretion of the concerned State Govt/UT Admn;
- Course fee/tuition fee/maintenance allowance will be credited to the student's (vi) bank account. Efforts will be made for transferring the same electronically through the bank.
- The State Govt./UT Admn. will maintain a separate account and records (vii) relating to the funds received from the Ministry and they will be subjected to inspection by the officers of the Ministry or any other agency designated by the Ministry;
- The student obtaining benefits under this scholarship scheme shall not be allowed to avail of benefits under any other scholarship scheme for the same purpose.
