**Subject: Grant-in-aid under the Centrally Sponsored Scheme of Merit-cum Means based Scholarship to the students belonging to minority communities to the Government of Rajasthan for the year 2013-14.**

Sir,

I am directed to convey the sanction of the President for release of non-recurring grant-in-aid of ₹ 4,60,64,971/- (₹ **Four Crore Sixty Lakh Sixty Four Thousand Nine Hundred Seventy One Only**) towards disbursement of 2039 (Two Zero Three Nine) scholarships, both fresh (1758 scholarships) and renewal (281 scholarships) to the Government of **Rajasthan** for the year 2013-14 as 100% Central share under the scheme of Merit-cum Means based Scholarships to the students belonging to minority communities, as per details enclosed at **Annexure 1 & II**. This includes a fund of ₹ 10,59,000/- (₹ **Ten Lakh Fifty Nine Thousand Only**) for administrative expenses for the year 2013-14 as per details enclosed at **Annexure III**. The non-recurring grant may be released to the Government of **Rajasthan** through CAS, Reserve Bank of India, Nagpur.

2. As per the utilization certificate submitted by the State, they have an unutilized balance of ₹ 83,23,139/- (₹ **Eighty Three Lakh Twenty Three Thousand One Hundred Thirty Nine Only**) from the previous year's releases from Merit-cum Means based Scholarship scheme. This amount has been adjusted from this release.

3. The expenditure is debitable to Demand No.68 - Ministry of Minority Affairs, Major Head "3601" - Grants-in-aid to State Governments, Sub-Major Head "04"-Grants for Centrally Sponsored Plan Schemes, Minor Head "378"-General (Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities) - Other Grants, 03 - Merit-cum-Means Scholarship for professional and technical courses for Minorities, 03.00.31 - Grants-in-aid- General for the year 2013-14.

4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format (GFR 19-A) within 12 months from the date of this Sanction Order.

5. The State Government/UT Administration should ensure that the sanctioned amount is utilized within one month from the date of crediting of fund in the account of the State.
