- Utilisation Certificates for 2013-14 received from the State Governments have been enclosed and final UC for grant-in-aid to the State Government will be 8. furnished at the time of releasing the grants for 2nd & final installment. It is also to be certified by the grantees that no utilization certificate is pending in respect of previous grant(s).
