Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration District to Government of Arunachal Pradesh for the year 2016-17 for Tirap District.

Sir,

In continuation to this Ministry's sanction letter of even number dated 21.08.2013 and 27.09.2013, I am directed to convey the sanction of the President for release of an amount of Rs 4,23,77,000/- (Rupees Four Crore Twenty-Three Lakh Seventy-Seven Thousand Only) as 2<sup>nd</sup> instalment to the Govt. of Arunachal Pradesh for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration Districts" for Tirap district as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Arunachal Pradesh through CAS, Reserve Bank of India, Nagpur.


2. The State Government should ensure that proportionate share of State share for the projects mentioned at Annexure-I is released to the implementing agency along with Central share.
3. The expenditure is debitable to Demand No.60, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Governments, 02- Grants for State Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes and Minorities) -Other Grants (Minor Head), 01 - Multi sectoral Development Programme for minorities, 01.00.35 - Grant for creation of capital assets for the year 2016-17.
4. A copy of the Utilization certificate of 1<sup>st</sup> instalment is enclosed. Further it is certified that no UC is pending for this project.
5. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Restructured Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificates and (iii) Report regarding release of the State share in case of innovative projects may also be furnished..



8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at Annexure-II.

- i. Grantee will maintain a separate account of the funds released by this Ministry under this scheme/programme.
- ii. The expenditure incurred by the grantee shall be open for inspection by the sanctioning authority/ Comptroller & Auditor General of India/Internal Audit by the Chief Controller of Accounts of the Ministry of Minority Affairs.
- iii. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
- iv. Grantee shall not divert any part of the grant to any other activities.
- v. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
- vi. Grantee shall endeavor to achieve the quantified and qualitative targets.
- vii. Grantee will ensure that there is no duplication of work.
- viii. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.

3. Further, it may be recalled that with the IFD's approval on the recommendation of 81<sup>st</sup> Empowered Committee for the district plans of **East Siang** district under MsDP was obtained vide our note at p.1-2/ante in respect of following projects:-

4. In view of above, we may release 50% of the central share i.e. Rs. 60.00 Lakh as 1<sup>st</sup> instalment to the Govt. of Arunachal Pradesh for implementing the above mentioned project in East Siang district. No UC for this project is pending as this is 1st instalment for these projects. We may also agree to the proposal for release of 2<sup>ns</sup> instalment and release remaining 50% of total cost of Central share, i.e. Rs. 100.95 Lakh as second instalment of the projects approved in 81<sup>st</sup> EC.

5. Accordingly, IFD's concurrence is sought for release of the amount of Rs. 160.95 Lakh (50% of Central Share) as approved in 122<sup>nd</sup> and 81<sup>st</sup> EC meeting.
