- 4. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP a permanent display would be installed.
- 5. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditions enclosed at annexure-II.
