The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.
- 5. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned enclosed at Annexure II.
