- 5. The Central Assistance being released is only for scholarships to the students. The requirement for administrative expenses to the states will be catered to at the time of release of  $2^{nd}$  & final installment.
- 6. The State Government should ensure that the sanctioned amount is made through contingency fund advance and that the sanctioned amount is disbursed to the students within one month from the date of receipt of fund in the State Account.
- 7. As per Rule 211(1) of G.F.R., the accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and internal Audit by the Principal Accounts Office of the Ministry.
- 8. Utilisation Certificates for 2013-14 received from the State Government has been enclosed and final UC for grant-in-aid to the State Government will be furnished at the time of releasing the grants for 2<sup>nd</sup> & final installment. It is also to be certified by the grantees that no utilization certificate is pending in respect of previous grant(s).
