The terms and conditions for annual contract(as mentioned in tender notice also) will be as under:-

- (i) The flowers should be of good quality and fresh. The flowers arrangements are to be made on alternate i.e. three days in week on Monday, Wednesday and Friday. If any of these days happens to be holiday, the arrangement will be made on next working day.
- (ii) There may be requirement of flower arrangement for meetings on working/non-working days and the same may have to be carried out, for which instructions would be given well in advance.
- (iii) The tender is not transferable. The firm shall not assign or sublet the work or any part of it to any other person or party.
- (iv) No payment shall be made in advance nor any loan from any bank or financial institution shall be recommended on the basis of the award of work. The contractor shall submit the bill at each stage/ in the first week of following month in respect of previous month (in case of monthly payments) for sanction of the amount of bill and passing the bill for payment. It is obligatory on the part of successful tender to furnish the detail of taxes, if any. All payment shall be made by cheque only. Ministry of Minority Affairs shall be at liberty to withhold any of the payment in full or in part subject to recovery of penalties mentioned in successding para.
- (v) The contract shall initially be for a period of one year from the date of acceptance of the order. The contract may be renewed for further period of one year with same terms & conditions, if the Department is satisfied, upto a maximum of two renewals.
- (vi) The firm shall provide all names and addresses of the persons engaged by it and certify the character antecedent of the individual employed by them for the work. The Ministry will issue them suitable identity cards, which shall be produced on demand by any of concerned officers. The firm and its employees will be subject to normal regulations relating to security of the premises from time to time. It is clarified that persons engaged by the firm to discharge its obligations under the contract shall be firm employees for all purposes and the Ministry shall not be held liable in any manner in respect of these persons. The firm shall be responsible for implementation of the provisions of all statutory requirements in license under the control Labour (Regulation) Act, 1970 or any other law in force and shall comply with all requirements under these Acts and the Rules framed there under.

- (vii) <u>Penalty</u>:- If the firm fails to attend to the request of the Ministry within the stipulated time/hours, the penalty shall be levied @2% of total bill amount of that month. Apart from the penalty levied as stated above, this will also entail termination of the contract.
- (viii) <u>Breach of Terms and Conditions</u>:- In case of breach of any terms and conditions mentioned above, the Competent Authority will have the right to cancel the work order without assigning any reason thereof.
- (ix) <u>Arbitration</u>: In case of any dispute arising between the contract holders or any constituent being party to the contract, the sole authority for settlement of such disputes will rest with the arbitrator appointed by the Secretary, Ministry of Minority Affairs.
- (x) <u>Jurisdiction</u>:- Failing arbitration in solving the disputes, the court at Delhi alone shall have the jurisdiction for all aggrieved parties i.e. the Department, the company or any constituent being party to the contract directly or indirectly.
